This filing is being made under authority of Special Permission No. 03-013 of the Federal Communications Commission. Sprint LTC proposes to withdraw the tariff language revising the definition of "Customer" originally filed January 17, 2003 under Transmittal No. 210, and reinstate the currently effective definition. This revision is being made on not less than one day's notice, and is scheduled to become effective February 1, 2003.

In addition, Sprint proposes to add tariff language in Section 5.2 to allow customers to place orders for access services directly or through a designated authorized agent. These revisions are being filed on 15 days' notice under the Federal Communications Commission's streamlined filing procedure, and are scheduled to become effective February 15, 2003.

In accordance with the requirements of Section 61.21(a)(3) of the Commission's Rules, the FCC Registration Number (FRN) for Sprint is 0003-7619-39. Sprint LTC is filing this transmittal on behalf of issuing carriers with the following FRNs:


