7.1.1 Channel Types (Cont'd)

70 MHz Transport (a.k.a. BellSouth SPA 70 MHz Transport) service provides for a 70 MHz, point-to-point, one-way, analog, intermediate frequency transport channel over dedicated fiber optic facilities. The customer interface for this service is a 75 ohm, -7.0 dbm signal with a bandwidth of 100 MHz centered on 70 MHz Carrier.

Uncompressed Switched Video (a.k.a. BellSouth SPA Uncompressed Switched Video) service is a fiber optic transport of high quality video service for customers who desire a BellSouth transport network that is controlled by the end-user. (T)
Two 15 kHz audio signals are provided with this service.

(A) Basic Description

An Uncompressed Switched Video (a.k.a. BellSouth SPA Uncompressed Switched Video) service channel is a channel that connects customer-designated video source(s) and video distribution location(s) through a customer-configurable video switch located at a Telephone Company Central Office (CO). Uncompressed Switched Video (a.k.a. BellSouth SPA Uncompressed Switched Video) service channels are single-direction and provided via fiber-optic facilities. This channel adheres to a standard 525-line/60-field, National Television Committee (NTSC) System-M video signal, and includes two 15 kHz audio signals.

- (1) Uncompressed Switched Video (a.k.a. BellSouth SPA Uncompressed Switched Video) service Local Channels (LC) (one way) provide connectivity of Single Channel or Multiple Channel Systems from each customer-designated end-location to its normal Serving Wire Center (SWC). Each Multiple Channel System also requires video channel activations. A customer may activate from one to six video channels per Multiple Channel System.
- (2) Uncompressed Switched Video (a.k.a. BellSouth SPA Uncompressed Switched Video) service Interoffice Channels (IOC) (one-way) provide connectivity of Single Channel or Multiple Channel Systems from the customer-designated location's normal SWC to the central office video switch.
- (3) Uncompressed Switched Video (a.k.a. BellSouth SPA Uncompressed Switched Video) service arrangements are available in two configurations that are available as independent, or in combination of, Single Channel Video Systems and/or Multiple Channel Video Systems. Each arrangement requires a minimum 36-month commitment period and a minimum of 8 video channels. Customers meeting the minimum 8 video channel/36 month commitment period requirement may request additional Single Channel Systems be associated with the same arrangement on a month-to-month basis. Both Single Channel Systems and Multiple Channel Systems will have an interface at the customer-designated end-location(s) with analog video and audio parameters as specified in TR-73593. Customer designated end-locations are video source locations (transmit) or video distribution locations (receive).

Customers are required to subscribe to a minimum of 8 video channels that connect the digital video switch to the customer designated end locations. These 8 video channels may be any combination of video channels on an Uncompressed Switched Video (a.k.a. BellSouth SPA Uncompressed Switched Video) service Single Channel and/or Multiple Channel System. (M)
