No.1 to withdraw tariff material associated with Transmittal No. 152, specifically language that seeks to include Collocation under Definitions in Section 2, General Regulations. Transmittal No. 152 was filed February 3, 2003 and has an effective date of February 18, 2003. Qwest is withdrawing the tariff material associated with Collocation in order to further explore the issue.
