This filing is being made on 15 days' notice under the Federal Communications Commission's streamlined filing procedure, and proposes the following revisions to Tariff F.C.C. No. 3:

- 1) Introduction of tariff language addressing the application of end user common line charges [commonly referred to as subscriber line charges (SLC)], presubscribed interexchange carrier charges (PICC) and local number portability (LNP) end user charges when customers subscribe to local telephone exchange services providing derived voice channels over a 2-wire facility used in conjunction with digital subscriber line (DSL) technology (i.e., voice over DSL or VoDSL);

- 2) Switched transport and special access rate adjustments resulting from the realignment of Sprint LTC's Midwest jurisdiction from three density pricing zones to four zones; and
- 3) Minor tariff language changes designed to clarify the provision of interstate access services.

Cost support material in accordance with Sections 61.38 and 61.41 through 61.49 of the Commission's Rules is provided, where required, for this filing. It should be noted that Sprint LTC notified affected customers of the revisions included in Transmittal No. 214 on or before the date of filing.
