Application is hereby made by John Staurulakis, Inc. (JSI) for Special Permission for a limited waiver of Sections 61.58 and 61.59 of the Commission's rules. A grant of this application will allow JSI to withdraw without becoming effective the filing made on behalf of Fort Bend Telephone Company (Fort Bend) to add Service Provider Number Portability (SPNP) service pursuant to Transmittal No. 76, on not less than one day's notice.

The FCC Registration Number (FRN) for Fort Bend is 0001-6880-27. The FRN for JSI is 0003-7481-42. Although Fort Bend is the only issuing carrier affected by the instant application, all of the issuing carriers for JSI Tariff F.C.C. No. 1 are listed on the attached page, with indication of each issuing carrier's respective FRN.

On February 11, 2003, in Transmittal No. 76, JSI made a filing with the Commission to establish Service Provider Number Portability (SPNP). As communicated to JSI by Fort Bend, based on discussions between Fort Bend and the Pricing Policy Division of the Wireline Competition Bureau, issues regarding rate development exist that support withdrawing the filing made under Transmittal No. 76. Based on the foregoing, JSI believes that good cause exists for granting of such waiver.
