Provision of a specialized data transmission service arrangement. This arrangement provides a dedicated Channel Extension Service (CES) network using dense wave division multiplexing (DWDM) in a ring topology. The architecture consists of fiber rings between customer premises using customer designated network equipment.

The initial network consists of channel services with maximum bandwidth of 1.25 gigabits per second as designated following:

- 12 CES Channels between 1500 Palisade Ave., Teaneck, NJ and 101 Barclay St., NY, NY.
- 3 CES Channels between 101 Barclay St., NY, NY and 5851 Westside Ave. North Bergen, NJ.
- 4 CES Channels between 1500 Palisade Ave., Teaneck, NJ and 1 Wall St., NY, NY.
- 3 CES Channels between 1500 Palisade Ave., Teaneck, NJ and 5851 Westside Ave., North Bergen, NJ.

Additional channels may be provided at any customer location dependent upon the Company's network capacity, consideration of applicable rates, and upon mutual agreement between the customer and Company. Subsequent channels requiring a different rate will be provided upon revision of this tariff.

The Company will monitor the service arrangement 24 hours per day, seven days per week and perform maintenance or repairs as needed. The customer will have read-only access to the monitoring system.

In addition to the initial service described above, the customer has the option of adding 1.25 Gbps Multiport Facility Arrangement(s) for the balance of the 60 month commitment period at the rates shown below if ordered by December 31, 2003. A 1.25 Gbps Multiport Facility Arrangement utilizes a multiport interface card which allows for up to four channels to be associated with a single wavelength.

This is a 60-month contract with a minimum period of 36 months, and is subject to early termination liability. When any 1.25 Gbps Channel service is terminated prior to the end of the 60-month contract period, a sum of \$3,127.00 is assessed for each month or fraction thereof remaining in the 36-month minimum period plus \$1,785.00 multiplied by the number of months remaining in the contract period. When any 1.25 Gbps Multiport Facility Arrangement is terminated prior to the end of the 60-month contract period, a sum of \$1,785.00 is assessed for each month or fraction thereof remaining in the contract period.
