In the filing, JSI proposes on behalf of Interstate and Warwick to make tariff revisions that will bring the application of the Federal Universal Service Charge (FUSC) into compliance with revised Section 54.712, effective April 1, 2003 as adopted by the Commission in the Contribution Methodology Order, released December 13, 2002.¹ With respect to multi-line business customers, this filing reflects the Commission's interim waiver of Section 54.712 to permit them to continue to recover through the Federal Universal Service line item certain contribution costs associated with Centrex customers on a per-line basis from multi-line business customers, pending action on petitions for reconsideration of this rule.²

Interstate and Warwick file both Traffic Sensitive and Common Line rates, including both Carrier Common Line and End User Common Line rates in JSI Tariff No. 1. Interstate and Warwick are not members of the NECA Common Line Pool.

Pursuant to Section 61.39 of the Commission's Rules, supporting information for Interstate Telephone Company will be furnished to interested parties upon reasonable request.

Pursuant to Section 61.38 of the Commission's Rules, JSI is providing a Description and Justification for this filing on behalf of Warwick Valley Telephone Company. Pursuant to Section 61.32(b) of the Commission's Rules, the original of this letter, Form 159, and a check for \$695.00 have been sent via overnight delivery to the Mellon Bank, Pittsburgh, Pennsylvania, as of this date.
