The filing is made on behalf of Interstate Telephone Company (Interstate) and Warwick Valley Telephone Company (Warwick), issuing carriers for JSI Tariff F.C.C. No. 1, and is made under authority of Special Permission No. 03-030 granted by the Federal Communications Commission on March 27, 2003.

This filing is being made for the following purposes:

1. Pursuant to Special Permission No. 03-030, this filing proposes revisions, prior to having been in effect for 30 days, to rates filed by JSI on behalf Warwick in Transmittal No. 79. Pursuant to Special Permission No. 03-030, the proposed effective date for the revisions filed under this transmittal is April 1, 2003 on less than fifteen day's notice. Additionally, as mentioned in the Application, revisions include expansion of the number of FUSC flat rate elements in order that the most common FUSC elements rates appear as line items in the tariff in lieu of being based on application of the FUSC Percentage Factor. This latter revision does not affect rates.

2. Also pursuant to Special Permission No. 03-030, this filing also proposes technical changes to the regulations in Section 3.9 of JSI Tariff F.C.C. No. 1 applicable to the Federal Universal Service Charge (FUSC). These changes do not affect the application or amount of the FUSC rates.

JSI and the issuing carriers, Interstate and Warwick, recognize that the filings made under Transmittal No. 79 and this transmittal on less than 15 day's notice will not be deemed lawful.

Pursuant to Section 61.38 of the Commission's Rules, JSI is providing a Description and Justification for this filing on behalf of Warwick Telephone Company. Prior to this transmittal, JSI had filed rate development pages for Warwick but had not yet filed with the Commission the narrative Description and Justification. Thus, the Description and Justification filed under this Transmittal applies to Transmittal Nos. 79, 80 and 81.

Pursuant to Section 61.39 of the Commission's Rules, supporting information for Interstate Telephone Company will be furnished to interested parties upon reasonable request.

Pursuant to Section 61.32(b) of the Commission's Rules, the original of this letter, Form 159, and a check for \$695.00 have been sent via overnight delivery to the Mellon Bank, Pittsburgh, Pennsylvania, as of this date.

Customers will be notified of the proposed changes in accordance with the Commission's requirements.
