The accompanying tariff material, issued on behalf of the Sprint local telephone companies (Sprint LTC) and bearing Tariff F.C.C. No. 3, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

This filing is being made on not less than one day's notice under authority of Special Permission No. 03-027 of the Federal Communications Commission and proposes to further modify Sprint LTC's USF end user charge to apply an equivalency ratio to the recovery of universal service contribution costs from Centrex customers and to average unrecovered contribution costs across multi-line business customers. In addition, Sprint LTC proposes to round up the second quarter contribution factor to the nearest tenth of a percent.

In accordance with the requirements of Section 61.21(a)(3) of the Commission's Rules, the FCC Registration Number (FRN) for Sprint is 0003-7619-39. Sprint LTC is filing this transmittal on behalf of issuing carriers with the following FRNs:
