NBTC proposes to introduce Data Trouble Management Services (DTMS). DTMS enables a participating Interexchange Carrier (IC) to receive, from the Telephone Company, specific trouble ticket information that relates to the IC's service after a trouble report has been initiated by a business customer who is utilizing that IC's interstate network. This service is further discussed in the attached Description and Justification.
