The accompanying tariff material, issued by the Verizon Telephone Companies (Verizon) and bearing Tariff F.C.C. Nos. 1, 11, and 16, Access Services, and Tariff F.C.C. No. 14, Facilities for Interstate Access, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. This material, filed on fifteen days’ notice and scheduled to become effective April 29, 2003, consists of tariff pages as indicated on the following check sheets:

With this filing, Verizon is proposing the following:

1. In its Tariff F.C.C. Nos. 1, 11, 14, and 16, Verizon is enhancing its IntelliLight[®] Optical Transport Service (IOTS) by introducing a 4-channel node, a multi-port facility interface optical transport channel, and additional Fibre Channel transmission speed options. Additionally, Verizon is replacing the ESCON transport channel single port option with a multi-port option. Verizon is also clarifying that the USOCs for SONET concatenated transport channels in Tariff F.C.C. Nos. 14 and 16 apply to Special Access transport only.
2. Verizon is clarifying the service description for its IntelliLight[®] Entrance Facilities (IEF) service in Tariff F.C.C. No. 11 to more closely conform to the service description for this service that appears in Tariff F.C.C. No. 1.
3. Verizon is modifying its IntelliLight[®] Dedicated SONET Ring (IDSR) service by correcting existing USOCs and correcting several rates in its Tariff F.C.C. No. 11. Verizon issued the 1st Revised Page 31-220 under Transmittal No. 206 on June 17, 2002, to revise monthly rate levels for IDSR nodes as follows:
 - The 3-year OC192 node was reduced to \$20,700.00
 - The 5-year OC48 node was increased to \$4,604.00
 - The 5-year OC192 node was reduced to \$11,500.00
 - The 7-year OC48 node was increased to \$4,143.00
 - The 7-year OC192 node was reduced to \$10,350.00

Verizon subsequently issued the 2nd Revised Page 31-220 under Transmittal No. 294 on February 21, 2003, which inadvertently carried forth the rates that were in effect prior to the rate level changes submitted and approved under Transmittal No. 206. This filing corrects the rate levels appearing on Page 31-220 to the rate levels currently in effect as approved under Transmittal No. 206.

In addition, Verizon is introducing new IDSR Channel Interface Codes in its Tariff F.C.C. Nos. 1 and 11.

Although supporting material as described under Section 61.49 of Commission's Rules is not required with this filing, a Transmittal Description is attached that outlines in detail the revisions being proposed under this transmittal. In addition, Figure 1 is attached for the new service options proposed for IOTS. Figure 1 will be used in the 2004 Annual Filing to demonstrate that these new service options should be granted the same Phase I or Phase II regulatory relief in the MSAs and the non-MSAs where the service category has been granted such relief.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).

Payment in the amount of \$695.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically over ETFS as a proprietary document.
