Unlimited Local and Toll Usage For Business (The Plan) is an optional calling plan for Business Dial Station customers in New York that combines local exchange usage and unlimited Intrastate IntraLATA Toll service, together with unlimited Interstate IntraLATA Toll service. Local exchange services and Intrastate IntraLATA Toll service are contained in Verizon New York Inc. Tariff P.U.C. No. 1.

(B) Terms and Conditions

- (1) The regulations included in this tariff cover only the Interstate IntraLATA Toll portion of The Plan.
- (2) The Plan is available only to Business customers that have enrolled in The Plan and selected the Telephone Company as its IntraLATA Toll provider.
- (3) Eligible Interstate IntraLATA Toll calls are those which are Business customer-dialed and completed without the assistance of a Telephone Company operator.
- (4) The Plan is not available in conjunction with any other Interstate IntraLATA optional calling plan.
- (5) The Plan allows the Business customer the ability to complete calls 24 hours a day, seven days a week, including holidays.
- (6) The Plan is not available to customers with 26 or more lines.

- (3) The monthly rate will be charged at the start of the first billing cycle after enrollment in The Plan.
- (4) There are no applicable enrollment charges or charges for discontinuing The Plan.
