In accordance with the Commission's requirements as specified in the Commission's *Order*, July 1, 2003 Annual Access Charge Tariff Filings, released April 18, 2003, DA 03-1175 ("*2003 Filing Order*"); and *Tariff Review Plans*, Material to be Filed in Support of 2003 Annual Tariff Filings, DA 03-1176, released April 18, 2002 ("*2003 TRP Order*"), Citizens is submitting revisions to its Price Cap Indices to be effective July 1, 2003.
