19. Promotional Offerings19.1 General

To receive the twelfth month of service at no charge, the customer must retain the service for at least twelve months. This offer applies to orders received from January 20, 2003 through February 18, 2003. To receive this promotional offer, a customer must place a completed order for new ADSL Channel service within the time period specified. If order completion is delayed due to Telephone Company reasons, the order completion date will be extended. This offering is not available with any other promotions.
