With this transmittal, Verizon is introducing a second subscription period for its Contract Tariff Option 3. Contract Tariff Option 3 was originally issued under Transmittal No. 305 on March 26, 2003, and provides DS1 and DS3 service plans for the New York-New Jersey Corridor. Contract Tariff Option 3 was filed pursuant to Verizon receiving Pricing Flexibility for Special Access Services in the New York-New Jersey Metropolitan Statistical Area (MSA)¹ The first subscription period for Contract Tariff Option 3 expires June 10, 2003.

Supporting material as described under Section 61.49 of Commission’s Rules is not required with this filing.
