**16.1 GENERAL**

A. Description

This section of the Tariff provides some of the regulations, and rates and charges that apply to the telecommunications services provided by the Company in the wire centers in which the Company has received Phase I and II Pricing Flexibility, pursuant to Subpart H of Part 69 of the Commission's Rules. Unless specified otherwise in this Section or Sections 23 and 24, other charges, terms, conditions, Termination Liability, ordering rules and other regulations specified in other sections of this Tariff also apply to the services provided in the wire centers in which the Company has received Pricing Flexibility

B. Service Availability

All services identified in Section 6, except Local Switching and other elements billed as minutes of use, are provided and rated out of this section for customers in the wire centers in which the Company has received Pricing Flexibility as specified in Section 23.

C. General

Regulations, applications of service, additional descriptions of services and rate elements may be found in Section 6. All regulations applicable to Section 6 Switched Access Service are also applicable to Section 16 Switched Access Service unless specified otherwise in this Section.

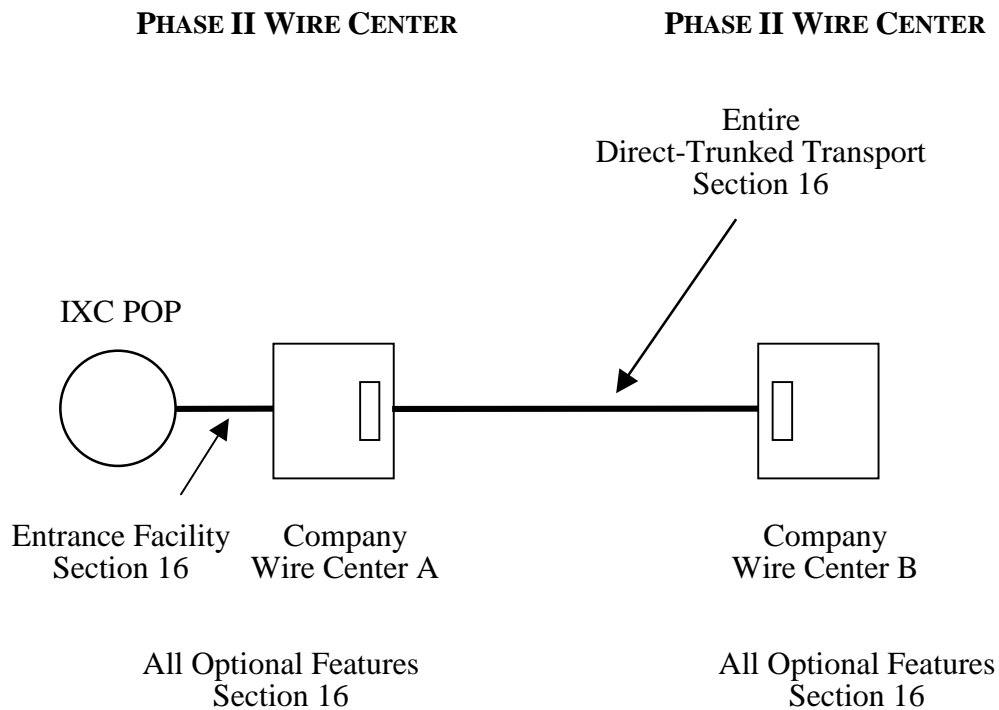

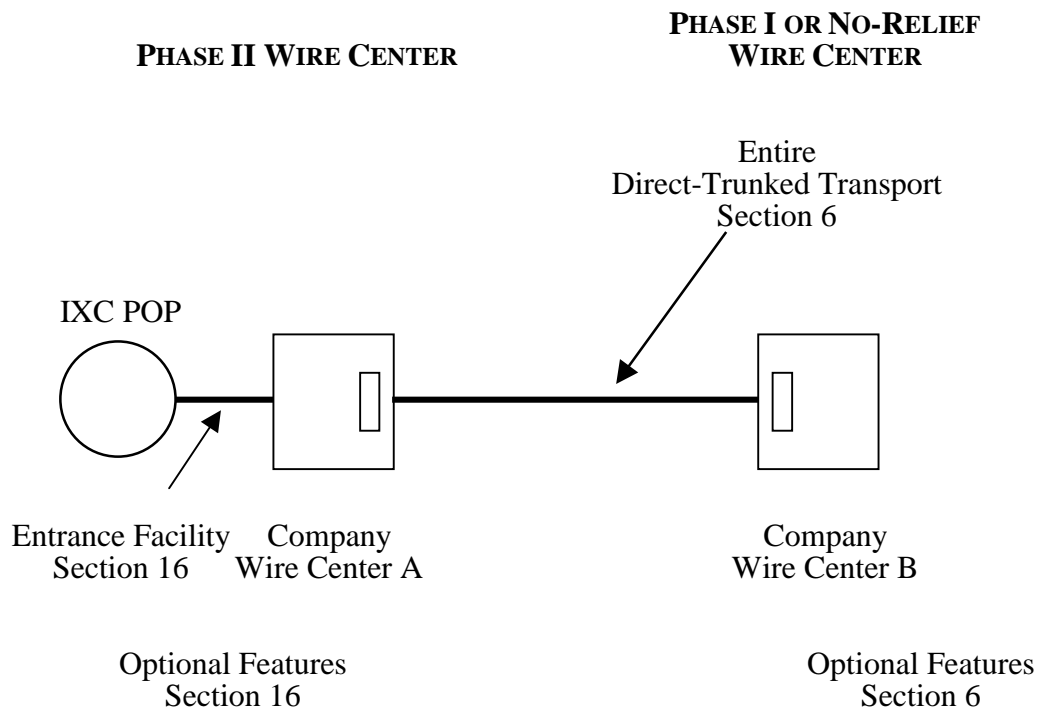

**16.2 RATES AND CHARGES**

Services that are Grandfathered in Section 6 are also Grandfathered for customers rated out of Section 16. As of February 28, 1998, DS3 Service Electrical and Optical Interface Capacity of 2 or greater are Grandfathered as set forth in 7.12.1.

Rates and charges for Non-Plan and Zones 1, 2 and 3 apply as set forth in 6.7.14. Density Zone rates are applicable only in Pricing Plan states as set forth in 6.7.15, preceeding. These services are for Shared Use only as set forth in 2.7.2, preceeding. Descriptions and regulations apply as specified in Section 6 or elsewhere in the Tariff unless specified otherwise in this section.

Customers with Pricing Plans prior to the implementation of Pricing Flexibility will retain those Pricing Plan rates until the expiration of the term. Customers with Pricing Plans, such as RCP, that do not stabilize the rates will be billed at the Section 16 rates if their wire center(s) has received Phase II Pricing Flexibility.
