With this filing, Verizon is filing revisions to introduce Verizon Infospeed Premium Digital Subscriber Line Service (Premium DSL). Premium DSL is a high-speed symmetrical (upstream and downstream data rates are equal) data-only access service. Five service level tiers are being introduced: 192/192 Kbps, 384/384 Kbps, 768/768 Kbps, 1.1/1.1 Mbps and 1.5/1.5 Mbps.

Supporting information as specified in Section 61.38 of the Commission’s Rules is included for the Tariff F.C.C. No. 20 portion of this filing. Certain information has been redacted as Verizon is seeking confidential treatment in a separate letter. The redacted information will be filed under seal pursuant to Sections 0.457 and 0.459 of the Commission’s Rules. In addition, Figure 1 identifies Premium DSL as a new Price Cap service for Tariff F.C.C. No. 1. Pursuant to

Paragraph 173 of the Commission's decision on pricing flexibility (FCC 99-206 Fifth Report and Order and Further Notice of Proposed Rulemaking, released August 27, 1999), Figure 1 demonstrates the basket and service category into which this service will be properly incorporated in the next Annual Filing in 2004.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).

Payment in the amount of \$695.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically over ETFS as a proprietary document.
