The F.C.C. Registration Number (FRN) for JSI is 0003-7481-42. The FRNs for the issuing carriers for JSI Tariff F.C.C. No. 1 are provided on the attached Transmittal 84 Appendix B.

The filing, to become effective July 1, 2003, consists of tariff pages as indicated on the following checksheet:

This transmittal includes, at Appendix A, a table listing the issuing carriers for JSI Tariff F.C.C. No. 1 which indicates the types of rate changes being made under this transmittal, if any, on behalf of each carrier.

In accordance with the Commission's April 18, 2003 release entitled In the Matter of Material to be Filed in Support of 2003 Annual Access Charge Tariff Filings, Tariff Review Plans, DA 03-1176 (2003 TRP Order), the instant filing includes revision of the rates for the provision of the applicable End User, Switched Access, Special Access and Miscellaneous Services offered by the issuing carriers filing pursuant to Section 61.39 in the JSI Tariff F.C.C. No. 1. The issuing carriers for JSI Tariff F.C.C. No. 1 are listed on the attached page, with indication of each issuing carrier's respective FRN.

In addition to the required biennial filings for the issuing carriers filing subject to Section 61.39 of the Commission's rules, this transmittal includes mid-course adjustment filings for two issuing carriers who file subject to Section 61.38 of the Commission's rules, Home Telephone Company (South Carolina) and Hargray Telephone Company (South Carolina). These filings reflect revisions in projected costs and demand to address under-earning.

For those issuing carriers who have tariffed individual company Carrier Common Line (CCL) rates, Interstate Telephone Company (Georgia) and Warwick Valley Telephone Company (New York and New Jersey), this filing serves to eliminate CCL rates effective July 1, 2003 consistent with the requirements of the *Rate-of-Return Access Charge Reform Order*, Multi-Association Group (MAG) Plan for Regulation of Interstate Services of Non-Price Cap Incumbent Local Exchange Carriers and Interexchange Carriers, CC Docket No. 00-256, Second Report and Order and Further Notice of Proposed Rulemaking, 16 FCC Rcd 19613 (2001) (*Rate-of-Return Access Charge Reform Order*). Because Warwick Valley Telephone Company's CCL rate has previously been reduced to zero – this filing serves more specifically to eliminate the element from the rate section. For those issuing carriers who reference National Exchange Carrier Association (NECA) Tariff F.C.C. No. 5 respecting CCL rates, this filing eliminates such references.

For two issuing carriers who have tariffed individual company End User Common Line (EUCL) rates in JSI Tariff F.C.C. No. 1, Concord Telephone Company (North Carolina) and Interstate Telephone Company this filing includes changes in single-line and multi-line business EUCL rates recalculated under, respectively for each company, Section 61.38 and Section 61.39 requirements to effect increasing the single line EUCL rate cap to \$6.50 effective July 1, 2003 pursuant to the *Rate-of-Return Access Charge Reform Order*. For Warwick Valley Telephone Company, who also tariffs EUCL rates in JSI Tariff F.C.C. No. 1, the filing does not include adjustment in EUCL rates because Warwick is a Section 61.38 filer whose current tariffed rate for both single line and multi-line business is \$5.98 tariffed effective July 2, 2002, thus making unnecessary any EUCL changes to effect compliance with the *Rate-of-Return Access Charge Reform Order*. All other issuing carriers make reference to NECA Tariff F.C.C. No. 5 and thereby will effect compliance with the revised EUCL single-line cap based on NECA's June 16th transmittal. Explanation of the changes in EUCL rates for Concord Telephone Company, who files pursuant to Section 61.38, is included in the Description and Justification for Concord Telephone Company. Also attached is an attachment explaining and supporting the change in the EUCL for Interstate Telephone Company who files pursuant to Section 61.39.

With respect to the increase in the Federal Universal Service Charge (FUSC) to reflect the proposed 9.5% Universal Service Fund Contribution Factor, see Federal-State Joint Board on Universal Service, CC Docket No. 96-46, Public Notice, DA 03-1909, released

June 6, 2003, this filing effects filings to increase FUSC charges and/or the FUSC Factor for the two issuing carriers not in the NECA Common Line Pool, Warwick Valley Telephone Company and Interstate Telephone Company. Support for Warwick Valley Telephone Company's increased FUSC charges and factors is included in the Description and Justification for Warwick Valley Telephone Company.

In addition, this filing cancels the rates for the provision of Switched Access, Special Access and Miscellaneous Services offered by Guadalupe Valley Telephone Cooperative, Inc. Effective July 1, 2003, Guadalupe Valley Telephone Cooperative will no longer provide interstate Switched Access, Special Access and Miscellaneous Services pursuant to the JSI Tariff F.C.C. No. 1. Instead, Switched Access, Special Access and Miscellaneous Services will be provided by Guadalupe Valley Telephone Cooperative, Inc. as an issuing carrier for NECA Tariff F.C.C. No. 5.

Pursuant to Section 61.38 of the Commission's Rules, cost support information, including explanation of compliance with implementation of the July 2 requirements of the *Rate-of-Return Access Charge Reform Order* is being furnished for the issuing carriers indicated on the above table as filing under Section 61.38. Also, the Tariff Review Plan schedules required by the *2002 TRP Order* are being provided (as directed for Rate-of-Return Carriers in the *2003 TRP Order*). The Transmittal includes attachments explaining compliance with the *Rate-of-Return Access Charge Reform Order* for companies filing under Section 61.39. Additional cost support for issuing carriers filing under Section 61.39 of the Commission's rules is available upon reasonable request by the Commission or interested parties.

The filings under this transmittal on behalf of the issuing carriers for JSI Tariff F.C.C. No. 1 do not reflect inclusion in cost or revenue data of amounts associated with actual or projected uncollectible revenue.
