The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Sections 61.58 and 61.59 of the Commission's Rules in order to withdraw material that is not yet in effect on less than statutory notice.

On July 1, 2003, Verizon filed Transmittal No. 333, which introduced Verizon Infospeed Premium Digital Subscriber Line Service (Premium DSL). On July 15, 2003, under Transmittal No. 339, Verizon filed supplements to defer the effective date of material filed under Transmittal No. 333 from July 16, 2003 to July 23, 2003. Verizon wishes to withdraw the material filed under Transmittal No.333 in order to make revisions requested by Commission Staff.

A waiver of Section 61.58 is necessary in order to make changes to material on less than statutory notice. A waiver of Section 61.59 is necessary in order to withdraw the pending filing.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).

Payment in the amount of \$695.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically over ETFS as a proprietary document.
