Under authority of Special Permission No. 03-076 of the Federal Communications Commission, Verizon is withdrawing material originally filed under Transmittal No. 333 on July 1, 2003. Transmittal No. 333 introduced Verizon Infospeed Premium Digital Subscriber Line Service (Premium DSL). On July 15, 2003, under Transmittal No. 339, Verizon filed supplements to defer the effective date of material filed under Transmittal No. 333 from July 16, 2003 to July 23, 2003. Verizon wishes to withdraw the material filed under Transmittal No. 333 in order to make revisions requested by Commission Staff.
