1. Promotional Offerings - Nonrecurring Charge Waivers (T)

a. November 1, 2002 – January 29, 2003 (T)

For each new ADSL Access Line ordered from November 1, 2002 through January 29, 2003, the Telephone Company will waive the nonrecurring service order and installation charges if the customer commits to retain the ADSL Access Line in service for a minimum period of 12 months following installation of service. If the ADSL Access Line is disconnected for any reason prior to the end of the 12-month minimum commitment period, the Telephone Company will bill the customer an amount equal to the waived nonrecurring charges.

1. Promotional Offerings - Nonrecurring Charge Waivers (cont'd) (T)

b. May 16, 2003 – July 31, 2003 (T)

For each new ADSL Access Line ordered from May 16, 2003 through July 31, 2003, the Telephone Company will waive the nonrecurring service order and installation charges if the customer commits to retain the ADSL Access Line in service for a minimum period of 12 months following installation of service. If the ADSL Access Line is disconnected for any reason prior to the end of the 12-month minimum commitment period, the Telephone Company will bill the customer an amount equal to the waived nonrecurring charges.

c. August 6, 2003 – October 31, 2003 (N)

For each new ADSL Access Line ordered from August 6, 2003 through October 31, 2003, the Telephone Company will waive the nonrecurring service order and installation charges if the customer commits to retain the ADSL Access Line in service for a minimum period of 12 months following installation of service. If the ADSL Access Line is disconnected for any reason prior to the end of the 12-month minimum commitment period, the Telephone Company will bill the customer an amount equal to the waived nonrecurring charges.
