**Re: Application for Special Permission**

Dear Ms. Dortch:

Application for Special Permission is hereby made on behalf of Iowa Telecommunications Services, Inc. d/b/a Iowa Telecom to waive Sections 61.58 and 61.59 of the Commission's Rules, 47 C.F.R. §§ 61.58 and 61.59 (2002), to withdraw, on same day's notice, proposed tariff revisions originally filed under Transmittal No. 37.

On July 29, 2003, Iowa Telecom filed tariff revisions to extend the availability periods associated with Iowa Telecom's limited ADSL special promotional offerings on 7 day's notice.

By this Application, Iowa Telecom seeks to make changes to these proposed revisions and file on 15 day's notice. Specifically, it seeks to file revised tariff pages to change the dates of the special promotional offerings.

Iowa Telecom requires a waiver of Sections 61.58 and 61.59 of the Commission's Rules in order to permit it to make revisions to tariff material that has not yet become effective. It is in the public interest for the Commission to grant this

waiver in order to ensure that customers do not experience multiple tariff revisions within a thirty-day period. Copies of illustrative pages are attached.
