Dear Ms. Dortch:

The accompanying tariff material, issued by Iowa Telecommunications Services, Inc. d/b/a Iowa Telecom ("Iowa Telecom"), and bearing F.C.C. No. 1, is sent to you in compliance with the requirements of the Communications Act of 1934, as amended.

This filing, to become effective September 10, 2003, on 7 days' notice under the Commission's streamlined tariff procedures, consists of tariff pages as indicated on the following check sheets:

Thirty-ninth Revised Page 1  
Twelfth Revised Page 2  
Twenty-first Revised Page 3

The purpose of Transmittal No. 39 is to reduce Iowa Telecom's average traffic sensitive ("ATS") target rate to 1.2015 cents per minute. As required by the Commission's rules and November 25, 2002 *Forbearance Order*,<sup>1</sup> Iowa Telecom is

submitting a revised forward-looking cost study dated September 3, 2003 (“September 3 Cost Study”) to support the 1.2015 cents per minute ATS target rate in this filing. The September 3 Cost Study is attached as Exhibit A to this filing. Because it includes proprietary and competitively sensitive information, Iowa Telecom is submitting the unredacted September 3 Cost Study as “not for public inspection.” Iowa Telecom requests confidential treatment of the unredacted September 3 Cost Study pursuant to section 0.459 of the Commission’s rules and the Protective Order issued by the Commission in WC Docket No. 03-135.<sup>2</sup> Consistent with the Protective Order, Iowa is submitting a redacted version of the September 3 Cost Study that is suitable for public inspection.

This filing revises rates proposed in Transmittal Nos. 31 and 32. On March 25, 2003, Iowa Telecom filed Transmittal No. 31, which proposed an ATS target rate of 1.4876 cents per minute based on a March 25, 2003 forward-looking cost study. On April 8, 2003, the Commission suspended Transmittal No. 31 for one day and then allowed it to take effect subject to an investigation, which is ongoing.<sup>3</sup> On April 10, 2003, Iowa Telecom filed Transmittal No. 32, which suspended for one day the effectiveness of tariff revisions filed under Transmittal No. 31 and corrected rates for DS1 Dedicated Trunk Ports submitted in Transmittal No. 31.
