(3) End User Port FUSF Charges

When a customer is assessed the BRI ISDN Port Charge as discussed in Section 4.6(H) preceding, an End User Port FUSF recovery charge will also be assessed as set forth in Section 4.7(I)(6) following.

(4) Other Non-recurring FUSF Charges

In addition to the applicable charges above, when a customer is assessed interstate end user charges identified in the table below, a FUSF recovery charge will also apply as set forth in Section 4.7(I)(7) following. For example, customers assessed the PIC change charge as specified in Section 13.3.3.(b)(5)(e)(ii) will also be assessed the PIC change FUSF recovery charge as set forth in Section 4.7(I)(7) following.
