This filing is being made on 15 days' notice under the Federal Communications Commission's streamlined filing procedures, and includes tariff language changes designed to clarify that pay telephone lines are not subject to the presubscribed interexchange carrier charge (PICC); addition of tariff language allowing Sprint SONET Ring Service customers to order OC3, OC12 and OC48 service using either 2-fiber unidirectional path switch ring (UPSR) or 2-fiber bidirectional line switched ring (BLSR) topology; and minor tariff language changes designed to clarify the provision of interstate access services.
