This filing is being made by Qwest in its Tariff F.C.C. No. 1, Section 8, Advanced Communications Networks, to add new rate/service elements and make other changes to its Local Area Network (LAN) Switching Service (LSS). Supporting information discussed under Section 61.38 or 61.49 of the Commission's Rules is included in the attached Description and Justification.

Qwest is also filing a Contract Tariff in Section 24, Contract Tariffs, for an Incentive Offering for DDS, DS1, DS3, SST or SHNS Service.

Qwest is filing this contract under the authority granted in Section 69.727 of the Commission's Rules and is in compliance with terms contained in Section 61.55 of the Commission's Rules.

Qwest is adding new rate/service elements and making other changes to GeoMax Private Line Transport Service in its Tariff F.C.C. No. 1, Section 7, Private Line Transport Service. The key additions and changes are as follows: 1) Adding a Central Office (CO) Node and a Network Access Channel (NAC) as new rate elements; 2) Changing the DWDM Node to a customer Premise Node; 3) Decreasing the Monthly Rate for several existing rate elements; 4) Revising the existing definition for mileage rate elements and; 4) Clarifying terms and conditions.

Qwest is making these changes in response to customer requests. These changes will also allow other Qwest services to connect to GeoMax allowing customers increased network design options and flexibility.

With respect to price changes, the attached Price Cap Tariff Review Plan and Workpapers (SP-1 provides Special Access Basket Detail, and SP-2 provides the Special Access Consolidated Weightings.) demonstrate that the Commission's rules with regard to price cap indices have been satisfied.

Corresponding GeoMax rate changes are also being made in Section 17, Private Line Transport Service – Pricing Flexibility.

As part of this filing Qwest is also adding language under its SONET Ring Service (SRS) to automatically extend SRS Partnership Program Pricing Plans that expire during 2003. These plans will be extended to December 31, 2003. This change is being made due to technical difficulties being experienced by Qwest in converting customers to new plans. This change does not impact tariff rates.

Qwest is also decreasing the Flexible Automatic Number Identification ("FLEX ANI") non-recurring fees under Common Switching Optional Features and BSEs, Automatic Number Identification. The proposed charge for FLEX ANI with associated trunk activity, per CIC Code, per end office is \$427.60 and the proposed charge for FLEX ANI without associated trunk activity, per CIC Code, per end office is \$466.76. In accordance with the Commission's price rules, Qwest is also increasing a number of local switching elements. The attached Price Cap Tariff Review Plan and Workpapers (TS-1 provides Traffic Sensitive Basket Detail, and TS-2 provides the Traffic Sensitive Consolidated Weightings.) demonstrate that the Commission's rules with regard to price cap indices have been satisfied.

Supporting information discussed under Section 61.38 or 61.49 of the Commission's Rules is, to the extent required, included in this transmittal letter and the attached Tariff Review Plan and Workpapers.
