With this filing, NBTC proposes the following modifications to the Expedite Charges found in NBTC's Tariff F.C.C. No. 1. NBTC will restructure the expedite charges application for High Capacity DS3 Access Services, establish new standard service intervals for High Capacity DS3 Access Services, make miscellaneous text changes and additions to existing tariff language for clarification purposes and make necessary modifications including adjustments to base period demand quantities and rate offsets to ensure price cap compliance.

Supporting information discussed under Section 61.49 of the Commission's Rules, to the extent applicable, is included with this filing in the attached Description and Justification.
