With this filing, NBTC proposes to make the following modifications to DS3 High Capacity Service, found in F.C.C. No. 1. NBTC will limit the month-to-month arrangement and the twelve-month extension to existing customers, establish a one-year minimum service period, establish monthly extension rates, limit the month-to-month rates to existing customers, establish a renewal process and clarify existing tariff language.

Supporting information discussed under Section 61.38 of the Commission's Rules, to the extent applicable, is included.


