With this filing, Ameritech proposes to grandfather the Anytime Rate Calling Plan for Illinois in Section 3 of F.C.C. No. 4. This option will no longer be available to new customers on or after, November 18, 2003. There will be no change to existing customers.

In addition, Ameritech proposes to modify the names of the existing Optional Calling Plans Solution Packages (Economy, Sensible, Complete, or 2-Line Complete Solution Packages) in Section 3 of F.C.C. No. 4. With this filing, the names will be Economy Local, Sensible Local, Complete Local, or 2-Line Complete Local Solution Packages.
