With this transmittal, Verizon is modifying its 1+ Coin Rating Service under its Tariff F.C.C. No. 11 to further clarify the provision of the service and to introduce a new nonrecurring rate element for the optional branding service.

In addition, Verizon is consolidating the rate pages for its End User Access Service in its Tariff F.C.C. No. 1 in order to group similar rate elements together and reduce the number of tariff pages required to list all the End User Access Service rate elements.

Supporting material as described under Section 61.49 of Commission’s Rules is not required with this filing.
