For Atlantic, the changes proposed under this transmittal are for the introduction of Frame Relay Access Service ("FRAS") and Asynchronous Transfer Mode-Cell Relay Access Service ("ATM-CRS Service"). Atlantic's proposed FRAS offering will be under the existing regulations in JSI Tariff FCC No. 1. Atlantic's proposed ATM-CRS Service offering will be offered under the ATM-CRS Service regulations introduced in JSI Transmittal No. 89 that will be effective on December 16th, 2003. This filing does not propose any changes to the ATM-CRS Service regulations. In addition to the proposed FRAS and ATM-CRS Service offerings, this filing also introduces, for ATMC's existing Asynchronous DSL ("ADSL") service, a DSL Network Reconfiguration charge and a DSL Nonrecurring Charge waiver option.

For CTC, this filing proposes introduction of a non-chargeable Optional Feature and Function to allow ordering by customers of connection of a customer STS-1 (Synchronous Transport System-1) to a Telephone Company 44.736 Mbps High Capacity Service Channel Termination.

For Fort Bend, this filing proposes reductions in rates for Asymmetrical Digital Subscriber Line ("ADSL") Service Term and Volume Discount plans.

For Interstate and WVTC, this filing proposes reductions in the Federal Universal Service Charge ("FUSC") Surcharge Factors to reflect the updated universal service contribution factor for the First Quarter of 2004 based on the Wireline Competition Bureau's Public Notice released September 5, 2003.¹ Interstate and WVTC file both Traffic Sensitive and Common Line rates in JSI Tariff No. 1. Interstate and WVTC are not members of the NECA Common Line Pool.

For Mt. Horeb Telephone Company, this filing serves to introduce Asynchronous DSL service under existing regulations in JSI Tariff FCC No. 1.

Lastly, for Star this filing proposes a reduction in the monthly charge for ADSL Service and introduction of a High Capacity 1.544 DSL Access Connection Charge.

Pursuant to Section 61.38 of the Commission's Rules, JSI is providing Description and Justification documents in this filing on behalf of CTC, Fort Bend and WVTC.

For Fort Bend, this filing also includes a request of the Commission for confidential treatment of Fort Bend's cost support information.

Pursuant to Section 61.39 of the Commission's Rules, supporting information for Atlantic, Interstate, MHT and Star will be furnished to interested parties upon reasonable request.


