All information received or reviewed by the customer or its authorized representative is to be considered confidential and is not to be distributed, provided or disclosed in any form to anyone not involved in the audit, nor is such information to be used for any other purpose.

3.8 Rate Regulations-Presubscribed Interexchange Carrier Charges (PICCs)

The Multiline Business PIZZ is billed on a per month basis to the interexchange carrier to whom an end user's Multiline Business access line is presubscribed or to a local service provider that resells services of the Telephone Company. In the event the end user does not have a presubscribed interexchange carrier, the Telephone Company will directly bill the Multiline Business PIZZ to the end user as set forth in 4.6 following.

When a payphone service is provided local business exchange service (N)
or coin line service, the Multiline Business PIZZ will not apply. (N)

When a customer is assessed the BRI ISDN Port Charge as discussed in Section 4.6(H) preceding, an End User Port FUSF recovery charge will also be assessed as set forth in Section 4.7(I)(6) following.

(4) Other Non-recurring FUSF Charges

In addition to the applicable charges above, when a customer is assessed interstate end user charges identified in the table below, a FUSF recovery charge will also apply as set forth in Section 4.7(I)(7) following. For example, customers assessed the PIC change charge as specified in Section 13.3.3.(b)(5)(e)(ii) will also be assessed the PIC change FUSF recovery charge as set forth in Section 4.7(I)(7) following.

To the extent an IC is assessed a PIC Change Charge, the Non-recurring FUSF charge will also apply to the IC.

(5) Special Access Services

A percentage surcharge factor is assessed monthly to end user billed Special Access recurring charges.
