The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Sections 61.58 and 61.59 of the Commission's Rules in order to withdraw material that is not yet in effect on less than statutory notice.

On December 4, 2003, Verizon filed Transmittal No. 388, which made revisions in Tariff FCC No. 20 to Transparent LAN Service to introduce a Network to Network Interface (NNI) Port With Access Line Connection. On December 12, 2003, Verizon filed Transmittal No. 390, which made the same revisions in Tariff FCC No. 1. After discussions with the Commission staff, Verizon has decided to withdraw one page from each of the filings and to reinstate material presently in effect on each of those pages.

A waiver of Section 61.58 is necessary in order to make changes to material which is not yet in effect. A waiver of Section 61.59 is necessary in order to make changes to these filings on less than statutory notice.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).

Payment in the amount of \$695.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically over ETFS as a proprietary document.
