Citizens Telecommunications Companies ("Citizens") submits this application for special permission to request waiver of the requirements of Sections 61.58 and 61.59 of the Federal Communications Commission's rules in order to file tariff revisions on not less than one days' notice to defer language which is scheduled to take effect February 28, 2004.

On February 13, 2004, Citizens filed Transmittal No. 145. In Transmittal No. 145, Citizens sought to add additional exchanges where Local Number Portability (LNP) is now available. The Commission's Staff has requested that the material filed under Transmittal No. 145 be deferred until March 7, 2004 due to the complex nature of the filing.
