The accompanying tariff material, issued by Citizens Telecommunications Companies ("Citizens") and scheduled to become effective February 28, 2004, is sent to you for filing in compliance with the Communications Act of 1934, as amended. With this filing, Citizens defers material filed under Transmittal No. 145 which was scheduled to become effective February 28, 2004.

On February 13, 2004, Citizens filed Transmittal No. 145. In Transmittal No. 145, Citizens sought to add additional exchanges where Local Number Portability (LNP) is now available. The Commission's Staff has requested that the material filed under Transmittal No. 145 be deferred until March 7, 2004 due to the complex nature of the filing. This filing relies on waivers of §61.58 and §61.59 of the Commission's rules granted under authority of Special Permission No. 04-013.
