##### Pay Telephone Line

The term "Pay Telephone Line" denotes facilities provided by the Telephone Company which connect pay telephone stations to the Local Exchange network.

##### Payphone Service Provider

The term "Payphone Service Provider" denotes one who provides payphone service, which is the provision of public or semi-public pay telephone, the provision of inmate telephone service in correctional institutions and any ancillary services.

##### Phase Jitter

The term "Phase Jitter" denotes the unwanted phase variations of a signal.

##### Point of Termination

The term "Point of Termination" denotes the point of demarcation, within a customer-designated premises at which the Telephone Company's responsibility for the provision of Access Service ends.

##### Ported Number

A Special Access (a.k.a. BellSouth SPA) Surcharge, as set forth in 7.4.2 following, will apply to interstate Special Access (a.k.a. BellSouth SPA) service provided by the Telephone Company to a customer, in accordance with regulations as set forth in Section 7 following.

4.5 Payment Arrangements and Credit Allowances

(A) Minimum Period

The minimum period for which EUCL End User Access Service s provided to an end user and for which charges are applicable is the same as that in the General Subscriber Service Tariffs for the associated local telephone exchange service.

(B) Cancellation of Application

End User Access Service s cancelled when the order for the associated local telephone exchange service is cancelled. No cancellation charges apply.

(C) Changes to Orders

When changes are made to orders for the local telephone exchange service associated with End User Access Service, any necessary changes will be made for End User Access Service. No charges will apply.

(D) Allowance for Interruptions

When there is an interruption to an EUCL, requested End User Access Service and Federal Universal Service (FUS) credit allowances for interruptions will be provided as set forth for credit allowance for interruptions in 2.4.4 preceding.

(E) Temporary Suspension of Service

When an end user temporarily suspends its local exchange service, which is associated with EUCL, one-half of the EUCL and FUS per month charge will be temporarily suspended for the time period the local exchange service is suspended.

4.6 Rate Regulations

- (A) End User Access Service and Federal Universal Service charges, as set forth in 4.7, following, will be billed to the end user subscriber of the associated local exchange service, including, where applicable, a reseller of the associated local exchange service, in which case the reseller shall be deemed an end user for purposes of application of such charges.

#### (A) Basic Channel Description

A High Capacity (a.k.a. BellSouth SPA High Capacity) channel is a channel for the transmission of nominal 64.0 kbps<sup>1</sup> or 1.544, 3.152, 6.312, or 44.736, Mbps isochronous serial data. The actual bit rate is a function of the channel interface selected by the customer. These channels are also provided at synchronous STS-1, OC-3, OC-12, OC-48, or OC-192 data rates. High Capacity (a.k.a. BellSouth SPA High Capacity) channels are provided between customer-designated premises or between a customer-designated premises and a Telephone Company Hub.

Except for DS1 Diverse service, a DS1 (1.544 Mbps) High Capacity (a.k.a. BellSouth SPA DS1) channel may also be provided over a fiber transmission path between a customer-designated premises and an alternate wire center. DS1 High Capacity (a.k.a. This DS1 Alternate Serving Wire Center (ASWC) transmission path avoids the wire center from which the customer would normally obtain dial tone. The ASWC local channel is provisioned between contiguous wire centers with adjacent fiber feeder routes. This service utilizes fiber facilities from the ASWC to the designated customer premises. Interoffice channel facilities, if required, will avoid the normal serving wire center. The Telephone Company will designate the serving wire center to be used as the alternate. (C)

If a busy line of circuit busy is encountered, the end user or location provider or its authorized agent will be instructed to dial the 800 telephone number, previously provided, at a later time.

The preferred IC will be billed applicable charges for the transfer as provided in 13.3.3(E), following.

(c) The preferred IC must comply with the following guidelines:

- i. The preferred IC must provide a dedicated 800 number for the end user or location provider or its authorized agent transfer.
- ii. On-Line Transfer service calls must be processed on a first priority basis, i.e. 95% of all calls transferred must be answered by the preferred IC within 30 seconds.
- iii. The preferred IC must process transferred calls within six minutes.

(d) The preferred IC must provide written notification thirty days prior to discontinuance of this service.

(3) If an IC elects to discontinue BellSouth SWA FGD or BellSouth SWA TSBA 3 service, the IC is obligated to contact, in writing, all end users or location providers or their authorized agents who have selected, or were allocated to, the canceling IC as their primary IC. The IC must inform the end user or location provider or its authorized agent within 90 (ninety) days that they are canceling their BellSouth SWAFGD or BellSouth SWA TSBSA 3 service; request that the end user or location provider or its authorized agent select a new IC with 30 (thirty) days; and state that the canceling IC will pay the change charge.
