The accompanying tariff material, issued by Citizens Telecommunications Companies ("Citizens") and scheduled to become effective March 6, 2004, is sent to you for filing in compliance with the Communications Act of 1934, as amended. With this filing, Citizens withdraws material filed under Transmittal No. 145 and was subsequently deferred in Transmittal No. 146, currently scheduled to become effective March 6, 2004.

On February 27, 2004, Citizens filed Transmittal No. 146. In Transmittal No. 146, Citizens deferred material from Transmittal No. 145 which sought to add additional exchanges where Local Number Portability (LNP) is now available. At the request of the Commission's Staff, this material is being withdrawn to allow further discussion on the LNP end-user charge development due to the complex nature of the filing. This filing relies on waivers of \$61.58 and \$61.59 of the Commission's rules granted under authority of Special Permission No. 04-016.
