On February 24, 2004, ICTC filed Transmittal No. 120 which proposed various modifications in its Tariff F.C.C. No. 2. The modifications included incorporating new special access high capacity term discount rates and language; revising and incorporating general regulations language for Payment of Rates, Charges and Deposits; incorporating new language for ordering options for switched access and special access; revising channel mileage termination language; increasing rates for basic and overtime labor; revising and incorporating new jurisdictional verification language; introducing Symmetric Digital Subscriber Line Access Service language and rates; and creating an offering for wholesale digital subscriber line rates.

Transmittal No. 120 was scheduled to become effective on March 10, 2004. With this filing, ICTC is withdrawing, without becoming effective, tariff pages filed in Transmittal No. 120 and to restore currently effective material. ICTC wishes to withdraw the aforementioned tariff pages in order to incorporate recommendations made by Commission Staff.
