In this transmittal, JSI proposes introduction of alternative rate regulations for Special Access Synchronous Optical Channel Service. On behalf of Smart City Telecommunications, LLC d/b/a Smart City Telecom ("SCT"), an issuing carrier for JSI Tariff F.C.C. No. 1, JSI proposes introduction of rates corresponding to the new regulations together with the addition of OC12 capacity. The new regulations and corresponding rates will not affect existing customers.

However, JSI is attaching a Description and Justification for the alternative Synchronous Optical Channel Service rate structure.
