19. Promotional Offerings

19.2 Terms, Conditions, Rates and Charges

The specific terms and conditions or rates and charges of each promotional offering are described below:

(A) ADSL Channel Promotional Offer for Service Ordered between February 18, 2004, and April 9, 2004 from Selected Companies

For a limited time only, local service subscribers of the companies described below may order installation of new ADSL Channel Class R1 or Class R2 service and receive the first month of service at no charge. In order to receive the first month at no charge, the customer must agree to retain the service for at least twelve months. If service is removed before the end of the twelve month commitment period, the customer must pay a termination liability equal to the normal tariffed rate for first month of service plus applicable taxes and surcharges. This offer applies to orders received from February 18, 2003 to April 9, 2003. To receive this promotional offer, a customer must place a completed order for new ADSL Channel service within the time period specified. If order completion is delayed due to Telephone Company reasons, the order completion date will be extended. This offering is not available with any other promotions.

This offer is available to subscribers of companies in Rate Group 1, Rate Group 2, and Rate Group 4 that offer the promoted DSL services.

(B) ADSL Channel Promotional Offer for Service Ordered between April 5, 2004 and May 30, 2004 from Ogden Telephone Company

For a limited time only, local service subscribers of Ogden Telephone Company may order installation of new ADSL Channel Class R1 or R2 service and receive the first, fourth, and eighth month of service at no charge. This offer applies to orders received from April 5, 2004 through May 30, 2004.
