#### 21.6 BellSouth Network Visibility Service (Cont'd)

##### 21.6.2 Maintenance

In order to maintain the quality of BellSouth NVS, the Company reserves the right to perform preventive maintenance and software updates. This could result in BellSouth NVS being unavailable during the time period between Midnight and 3:00 A.M. Eastern Time on Sundays. In addition, preventive maintenance may be performed on the XAFRS (a.k.a. BellSouth Exchange Access Frame Relay Service), XAATMS, MSFRS and MSATMS circuits being monitored by NVS during the time period between 2:00 A.M. and 4:00 A.M. Eastern Time on the specific days as set forth by state in the following chart. BellSouth NVS will be unable to view these circuits while preventive maintenance is being performed. The Telephone Company only expects to utilize this maintenance window on the average of once a quarter. However, the Telephone Company reserves the right to perform maintenance at any time at its discretion that it believes such maintenance is necessary. The Telephone Company will make a reasonable effort to provide notice to those customers likely to be affected by such maintenance work.

21.6.4 Rate Regulations

- C. For a promotional period from January 17, 2004 to April 16, 2004, Non- (T)  
Recurring Charges are waived for the following services: 1) BellSouth  
Exchange Access ATM Service (XAATMS) and BellSouth Exchange Access Frame  
Relay Service (XAFRS) Network Interfaces; 2) BellSouth Managed Shared  
ATM Service (MSATMS) and BellSouth Managed Shared Frame Relay Service  
(MSFRS) Connections; 3) Network Visibility Service (NVS) Fault  
Management and On Demand Statistics and NVS Fault Management, On Demand  
Statistics and Performance Reports per Network Interface or Connection.  
The following criteria must be met:

1. Network Interfaces or Connections ordered under this promotion must  
remain in place for a minimum of 6 months;
2. The service application date must occur during the promotion period.

The Non-Recurring Charge will be assessed if a circuit that has received  
free installation is disconnected prior to the six-month period  
expiring.

- D. For a promotional period from April 17, 2004 to June 16, 2004, Non- (N)  
Recurring Charges are waived for BellSouth Network Visibility Service (N)

received free installation is disconnected prior to the six-month period (N)   
expiring. (N)
