MUNICIPAL BUSINESS LICENSE TAX REVISION
TRANSMITTAL NO. 811

With this filing, BellSouth Telecommunications, Inc., (hereinafter "BellSouth"), is revising Tariff F.C.C. No. 1, Section 2, General Regulations, to add the municipal business license tax at a rate of .75% applicable to interstate customer receipts in Society Hill, South Carolina. In addition, the municipal business license tax factor for the city of Atlanta, GA is being changed to 4.10%. BellSouth will bill the municipal business license on interstate receipts in accordance with existing tariff regulations in Section 2.4.1(J).

Transmittal No. 811 is being filed on April 16, 2004 and is scheduled to become effective May 1, 2004.
