With this filing, NBTC proposes the following modifications to the Cancellation of an Access Order found in NBTC's Tariff F.C.C. No. 1. NBTC will restructure the cancellation charges application for the following Special Access Services: Gigabit Ethernet Metropolitan Area Network (GigaMAN), Multi-service Optical Network (MON) Ring Service and Optical Carrier Network (OCN) Point-to-Point Service, make miscellaneous text changes and additions to existing tariff language for clarification purposes and make necessary modifications including adjustments to base period demand quantities and rate offsets to ensure price cap compliance.

Supporting information discussed under Section 61.49 of the Commission's Rules, to the extent applicable, is included with this filing in the attached Description and Justification.
