The accompanying tariff material, issued by the Verizon Telephone Companies (Verizon) and bearing FCC No. 20, Communication Services, and FCC No. 21, Special Construction, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. This material, filed on fifteen days’ notice and scheduled to become effective May 12, 2004, consists of tariff pages as indicated on the following check sheets:

1. This filing, issued under authority of Special Permission No. 04-028 of the Federal Communications Commission, makes numerous revisions to Frame Relay Service provided to customers in the States of Maine, Massachusetts, New Hampshire, New York/Connecticut, Rhode Island and Vermont (Part I, Section 5.1). Frame Relay Service is a medium to high speed connection-oriented packet switched data service that allows for the interconnection of Local Area Networks or other compatible customer equipment across a wide area for the purpose of interstate access. A detailed Description of the revisions and a copy of the customer notification letter distributed on April 23, 2004, are provided as attachments to this filing.

Frame Relay Service is an interstate special access service utilizing category 1.2 facilities, as defined in Section 36.154, and is not a “loop-based” service per the definition in paragraph 61.3(yy) of the Commission’s rules). Therefore, pursuant to paragraph 61.49(f)(3), the new services associated with this filing are being filed without cost support. The rate changes of existing rate elements proposed in this filing are submitted without API and SBI supporting data because Frame Relay Service has not yet been incorporated under the applicable price cap indexes.

2. This filing provides for Special Construction of facilities to provision tariffed services in Tariff FCC No. 21 for the following:

MA – Computer Sciences Corp.; NY – AT&T, Pfizer, Verizon Wireless, Consolidated Edison Co. of NY; NJ – E Commerce Group; DC – Corporate Executive Board; MD – US Cellular; VA – Nextel Communications; OR – Verizon Wireless; NC – Verizon Global Networks; FL – Verizon Wireless.

Supporting material as specified under Section 61.38 of the Commission’s Rules is included with this filing.

Also with this filing, Verizon is deleting two cases cancelled by the customer prior to construction of facilities, moving a case to another page (it was put on the wrong page associated with the work location), and correcting a Monthly Recurring Charge that was a typographical error (in the filing only). The contract shows the correct Monthly Recurring Charge.

Payment in the amount of \$695.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically via ETFS.
