Qwest is filing a Contract Tariff in Section 24, Contract Tariffs, for an Incentive Offering for DS1, DS3, Synchronous Service Transport (SST) and/or Self-Healing Network Service (SHNS). Qwest is filing this contract under the authority granted in Section 69.727 of the Commission's Rules and is in compliance with terms contained in Section 61.55 of the Commission's Rules.

As part of this filing, Qwest is also correcting a tariff reference contained in Section 8, Advanced Communications Networks, under the QWEST DSL Volume Plan Starter Option. In this section Qwest incorrectly referenced the Basic Discount Option where it should have referenced the Starter Option.

Qwest is also zero-rating the Local Number Portability End User Charge listed in Section 13.19.2, Local Number Portability End User Charge. Qwest's tariff permitted Qwest to assess the rate in all states, except Oregon, Washington, and Northern Idaho (Spokane, Washington LATA) through February 9, 2004. The tariff permitted Qwest to assess the rate in Oregon, Washington and Northern Idaho (Spokane, Washington LATA) through March 14, 2004. Qwest is zero-rating the end user charge to clarify the tariff for customers.
