DESCRIPTION AND JUSTIFICATION
MISCELLANEOUS TARIFF REGULATIONS AND RATES CHANGES
TRANSMITTAL NO. 820

With this filing, BellSouth Telecommunications, Inc., (hereinafter referred to as "BellSouth"), is revising its Access Services Tariff, F.C.C. No. 1 to make miscellaneous regulations and rates tariff changes to clean up some inaccurate references and clarify tariff regulations and rates regarding the Access Services provided in Tariff F.C.C. No. 1.

The miscellaneous regulations and rates changes are as summarized below:

- Section 3 is being revised to move Section 3.7, Reserved for Future Use, from page 3-5 to the correct place in Section 3 which is on page 3-10. In addition, the remaining tariffs regulations and rates in this section are being moved up to page 3-10.1, without change, to do use the blank pages in this section.
- Section 7.4.1(C)(3) is being revised to correct the spelling of "charge" in the rate regulations for Service Rearrangements. In addition, Section 7.5.18(B)(4)(c) is being revised to add verbiage to clarify a FlexServ rate element description
- Section 13.3.23 is being clarified to state that Physical Access Cross Connects provide a one to one dedicated transmission path between the ordering customer's tariffed service offerings or transport equipment located in the Telephone Company Central Office and the ordering customer's own physical collocation arrangement or another telecommunications carrier's (collocator's) physical collocation arrangement. In addition, Sections 13.3.23(3) and 13.3.23(4) are being corrected to be Sections 13.3.23(8) and 13.3.23(9).
- Miscellaneous USOCs and BCOS corrections are being made in Sections 21 and 23 to meet billing needs (non rate impacting). In addition, certain tariff pages in Section 21 are being revised to correct the alphabetical order of certain tariff regulations.

- Sections 23.4.B, 23.4.D and 23.4.E are being revised to add references to Sections 28 and 29
- Section 23.5.2.18 is being revised to add verbiage to clarify a FlexServ rate element description. In addition, certain pages in Section 23 are being revised to re-alphabetize XAFRS/MSFRS/XAATMS/MSATMS Services USOCs in the Pricing Flexibility USOC Indicator tables
- Section 25 is being revised to delete expired promotions

Transmittal No. 820 is being filed on May 13, 2004 and is scheduled to become effective on May 28, 2004.
