7.18.1 GENERAL (Cont'd)

C. Availability

1. GeoMax is available as specified in the NECA TARIFF F.C.C. NO. 4, and contemplates the use of existing facilities. There may be occasions when GeoMax is not available due to facilities limitations, or when it may be necessary to construct facilities. If Special Construction is involved, the regulations as set forth in Tariff F.C.C. No. 2 apply.
2. GeoMax Service can connect to the following Company provided services: ATM, SST and SHNS. Such connections must be made at a CO Node.

D. Rate Categories

The basic rate categories that apply to GeoMax are:

- Premise Node, equipped with one shelf (described in D.1., following)
- CO Node, equipped with one shelf (described in D.2., following)
- Network Access Channel (NAC), (described in D.3., following)
- Additional Shelf (described in D.4., following)
- Amplifier Node (described in D.5., following)
- Transport Channels (described in D.6., following)
- Ports (described in D.7., following)

Rates and charges for PLTS (e.g., DS1 or DS3 Service) and/or Switched Access Services, as detailed in Sections 6 and/or 7, preceding, and Sections 15, 16 and/or 17, following, apply for each PLTS or Switched Access Service that connects to GeoMax. The Company will not apportion the monthly billing when Switched Access Services connect to GeoMax.
