In addition to the rates and charges associate with the CSM optional feature, nonrecurring charges for the design change may also apply. The Company's ability to provide CSM on a particular ring may be limited by the overall configuration of that ring. Reconfiguration is limited to those circuits that originate and terminate on the ring (i.e., at locations served by a node on the ring) and utilize ports that are symmetrical.
