Citizens Telecommunications Companies ("Citizens") submits this application for special permission to request waiver of §61.58 and §61.59 of the Federal Communications Commission's rules in order to file tariff revisions on not less than one day's notice changing material which has not yet gone into effect.

On May 17, 2004 Citizens filed Transmittal No. 149, which is scheduled to become effective on June 1, 2004. In Transmittal No. 149, Citizens reduced the recovery period of its Local Number Portability (LNP) Surcharge rate element for exchanges where this charge is already in effect, under authority of a waiver of §52.33(a)(1)(iv) of the Commission's rules granted by an *Order* released by the Commission On April 30, 2004 (DA 04-1252). After Transmittal No. 149 was filed, a clerical error was discovered in the ending effective date of the LNP Surcharge for Blooming Prairie, MN and its remotes. Citizens seeks the above-cited waiver of §61.58 and §61.59 to correct this clerical error while retaining the June 1, 2004 effective date.

In accordance with the Commission's fee filing requirements, the original of this Application (without revised tariff material), together with a completed FCC Form 159 and a check payable to the Federal Communications Commission in the amount of six hundred ninety five dollars (\$695.00), has been forwarded to the designated office of the Mellon Bank in Pittsburgh, Pennsylvania.
