Wholesale Digital Subscriber Line (DSL) Transport Service is a high-speed data access service that is made available to Network Service Providers for provision of high speed data and IP Protocol multicast video services to their customers. Wholesale DSL Transport Service is provided to the customer through connection to the Telephone Company DSL Access Service Connection Point. Connections to the DSL Access Service Connection Point may be available through a Telephone Company's Asynchronous Transfer Mode (ATM) connection under Section 16.7.4 or a Telephone Company High Capacity DSL Access Connection under Section under Section 7.10.3(E).

The Telephone Companies listed in the table below offer Wholesale DSL under this tariff section. The Telephone Companies offer Wholesale DSL with either an ATM connection or High Capacity DSL Access Connection or both as indicated by an "X" in the applicable column in the following table. Additionally, those Telephone Companies offering Video Wholesale DSL Service under this tariff section are indicated.

16.8.5 DSL Rate Regulations (Cont'd)(H) Video Wholesale DSL (VWDSL) Service

Where suitable facilities exist, a customer that requires the ability to send high-speed video transmission may order Video Wholesale Digital Subscriber Line (VWDSL) Service as an optional function under Wholesale DSL Transport Service. VWDSL Service comprises two paths within the Telephone Company's Wholesale DSL network. The first path is a Multi-Cast Virtual Path (MCVP) connected to the Telephone Company's Wholesale DSL network at the DSL Access Connection Point through an ATM-CRS port and continuing through the Telephone Company's ATM-CRS network to the Multicast aggregation points at the Digital Subscriber Line Access Multiplexers (DSLAMs) or similar Telephone Company broadband multiplexer equipment serving end user customers. The second path is a Virtual Path from the DSLAM or similar broadband multiplexer equipment to the premises of the end user customer.

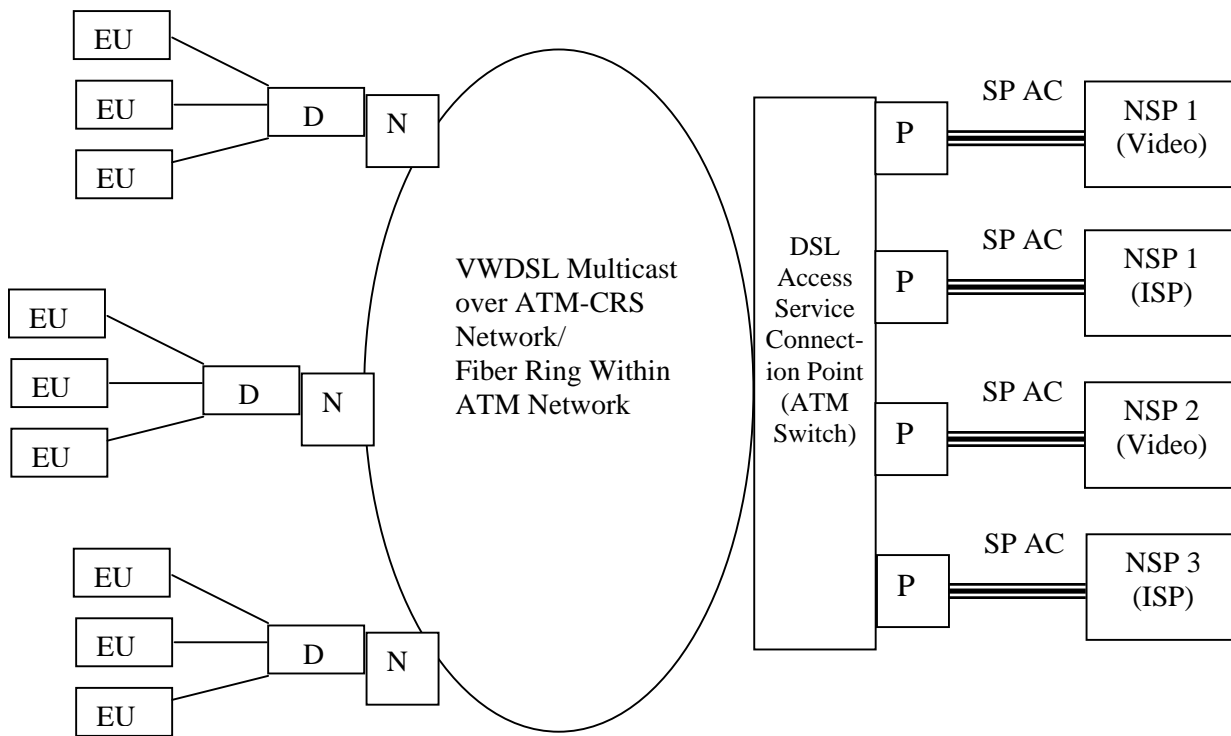
Customers may order VWDSL Service for both end user customers for whom the Customer has also ordered Wholesale DSL Transport Service and for end user customers who wish to receive video only.

The following rate elements apply to VWDSL in lieu of Wholesale DSL Access Line charges described above at 16.8.2(E).

(a) VWDSL Multicast Virtual Path

The Telephone Company's Wholesale DSL Network delivers video data to DSLAMs by ATM-CRS technology carried over a synchronous optical channel network comprising part of the Telephone Company's ATM-CRS network. Because the synchronous optical channel network utilizes a ring configuration, the Telephone Company employs technology that allows a single Virtual Path to deliver one programming channel to all DSLAMs connected to the Telephone Company's ATM-CRS network. The video data both "drops off" and "continues."

The Customer must order one VWDSL-Multicast Virtual Path for each channel of programming that the Customer may provide, including both scheduled programming, and where facilities support, "Video On Demand" services. Each VWDSL-Multicast Virtual Path will support up to a maximum of three Mbps of data.

The VWDSL Access Line Charge recovers the cost of provision by the Telephone Company of a Virtual Path between the DSL Access Connection Point and the end user customer premises. The maximum downstream speed of data is 9 Mbps from the DSL Access Connection Point to the end user customer premises. The maximum upstream speed of data is 128 kbps from the end user customer premises to the DSL Access Connection Point.

The VWDSL Access Line Charge only applies to WDSL Access lines serving end user customers who are not also served by WDSL Transport Service subject to the WDSL Access Line Charge.

(c) ATM-CRS NNI Port Charge

Customers ordering VWDSL Service must also order appropriate ATM-CRS NNI Ports under Section 16.7 of this tariff. Additionally, Customers must order appropriate Special Access channel termination(s) or channel mileage facilities and terminations under Section 7 of this tariff.

(2) Term and Volume Discount Plan (TVDP)

The Term and Volume Discount Plan (TVDP) provisions of Section 16.8.5(G) above apply to VWDSL Service. For purposes of volume discounts, all lines subject to the VWDSL Access Line Charge shall be included in determination of the volume level for purposes of both WDSL Transport Service and VWDSL Service.

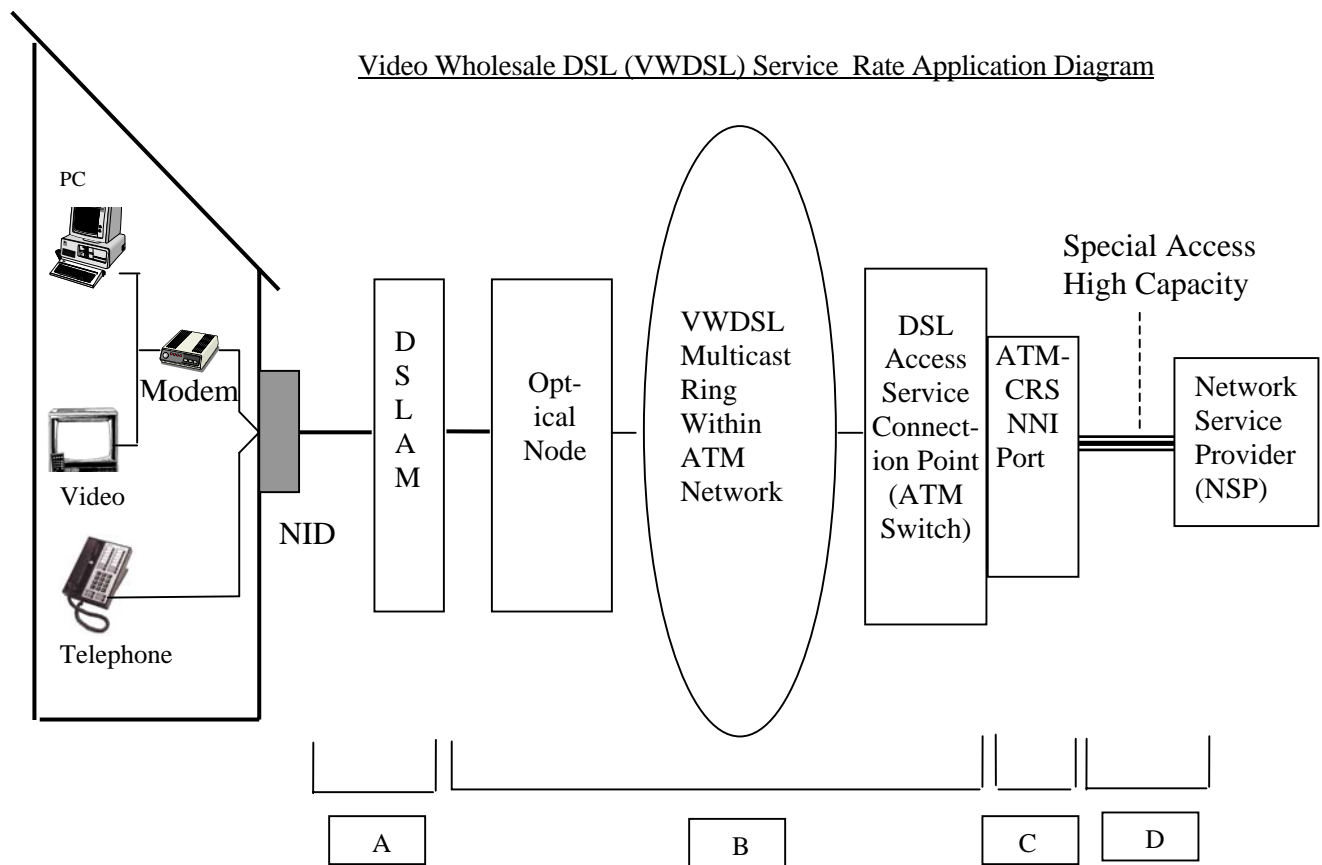
